Dear Hon Morlu:

I present you my compliments and herein acknowledge receipt of the letter of April 13, 2010 signed by the Human Resource Director in which you seek to demote or reclassifying my job title from Junior Supreme Auditor to an Audit Trainee with your knowledge and approval, effective April 1, 2010, although said letter was delivered and received on April 15, 2010..

Sir like previous actions, this letter I believe originated from you as the Auditor General of Liberia. As you are aware, I held the position of Secretary to the Auditor General and did serve three (3) Auditor Generals with creditable performance record prior to your appointment. And even after your appointment and subsequent assumption of duty, you commended me on several occasions for my able management of the office of the Auditor General. Disappointedly, for no professional reason and contrary to the Civil Service regulations and the GAC Human Resource Policy, you demoted me to the position of Receptionist in December 2007 with massive cut in my salary/allowance from US\$400.00 to US\$181.00. On September 18, 2008, you promoted me to the position of Administrative Officer with a salary/allowance US\$264.00, on December 3, 2008; you transferred me to the position of Junior Supreme Auditor even though I had no previous training in auditing. The salary/allowance here was also less than that of the Secretary. I have no doubt that a trainee salary/allowance will be less.

I am made to further believe that your actions are self seeking and intended to humiliate me, undermine my confidence, and put me in the position to become vulnerable to your many sexual advances. I refused to be lured into succumbing to your games. As I told you on numerous occasions, I stand to be wrongfully dismissed

from the GAC than to fall to your sexual desires. I intend to continue to work professionally at the GAC.

Now I am even more suspicious and believe that your actions targeting my husband, Mr. Alexander P.B. Yeaher, by presenting him to the President of Liberia, on April 5, 2010, as a thief of county development funds which has led to the withholding of his induction into office after his confirmation by the Liberian Senate, on April 1, 2010, as Assistant Superintendent for Development for River Gee County is all part of your scheme to force me to accept your sexual advances. I am totally embarrassed and frustrated by this game. Accordingly, I have decided to go public and seek justice against your unprofessional and unethical behavior towards me.

Please stopped harassing me sexually, and please deal with me professionally consistent with the rules lay down in the Civil Service regulations and the GAC Human Resource Policy.

Considering the seriousness of this matter, I have further decided, by copy of this letter:

1. To request the Civil Service Agency (CSA) to conduct an investigation into your unprofessional and unethical behavior with the aim to restoring my interest, honor and dignity, and according to known policy governing demotions and promotions,
2. To request the Association of Female Lawyers (AFFELL) and the Justice and Peace Commission (JPC) to represent my interest in this investigation and more,
3. To request the European Union (EU) to intervene in this matter since you boast that they are the only people who can take action against you because they are your employer and not the Government of Liberia,
4. To report you to the National legislature as a branch of government with the statutory mandate to supervise the work of the General Auditing Commission (GAC), and
5. To take the matter to the public in order to save my good name and that of my husband since you are known to do your business in the media.

I am appealing for justice to save my family, especially the dignity of my husband, Mr. Yeaher, our two (2) little children and our many extensions.
