Whereas the elders of Plandabelebo, including the Paramount Chief of Seekon Chiefdom, Since County, gave 500 acres of land to Mother Eliza Davis-George to build a mission station and:

Whereas Mother Eliza Davis-George sent me to the United States in 1954 to be educated to take over her work after my return from the United States to Liberia and:

Whereas Mother Eliza Davis-George turned over the E. N. I. Mission to me after I returned to Sinoe County in 1965 and:

Whereas I became the Director of the E. N. I. Mission and Chairman of the Board of Directors of the mission; and

Whereas I remained Chairman of the Board of Directors of E. N. I. Mission even after I made Bishop Amos N. Chea the Director of the mission in 1982 when I moved to Monrovia where I founded the Ministry of Hope Television Ministry and;

Whereas the Liberia's 14 years of Civil War destroyed practically every infrastructure in the nation including the E. N. I. Mission station and;

Whereas my wife Othelia and I fled to the United States for refuge from the Civil War and Bishop Chea and his family fled to the Ivory Coast from the same civil war and:

Whereas Mr. Klahn-Gboloh Jarbah, son of Ma Kumuteh, who was the leader of the women in Plandabalebo and Klahn-Gboloh also being the nephew of Paramount Chiefdom Ganty who was the chief that together with his elders signed the certificate for 500 acres of land which was given to Mother Eliza Davis-George for the purpose of building a mission station for the education of Liberian children and;

Whereas Mr. Klahn-Gboloh Jarbah, a product of E. N. I. Mission, has a vision and a passion to rebuild the Mission;

Therefore, I, Bishop Augustus B. Marwieh, the Successor of Mother Eliza Davis-George and Chairman of the Board of Directors of E. N. I. Mission, do hereby appoint Mr. Klahn-Gboloh Jarbah as my successor and as Chairman of the Board of Director and CEO; and Executive Director of the E. N. I. Mission with all the rights and privileges to retrieve and affix signature to all land deeds, if any, relating to E. N. I. Mission; to reorganize the Board of Directors of E. N. I. Mission and; to undertake the reconstruction of the E. N. I. Mission to the glory of God and for the benefit of our people and their children.
